

Terms & Conditions - " Cashback Offer - GIGABYTE & AMD "

This promotion - " Cashback Offer - GIGABYTE & AMD " will be executed by GIGABYTE TECHNOLOGY CO., LTD. and eligible Partners. The customers accept the following terms and conditions ("T&C") by their participation (article 9: "Approval").

1. Legal conditions

This information about the cashback offer and participation, combined with the GIGABYTE Terms of Use Notice and the GIGABYTE Privacy Policy, are the basis of these T&Cs. **The promotion is limited (first 800 participants)** and by participating in the promotion, the customer agrees to these T&Cs. 4. Subject and rules of participation

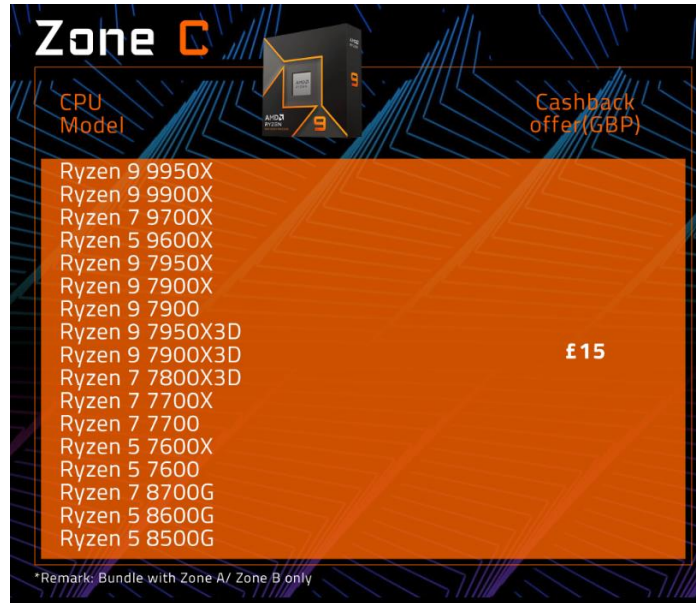
